Environmental Policy

Clean business practices protect the environment

Soldiers Point Marina is committed to the creation and ongoing maintenance of a clean and safe working environment. We will be diligent in best practice management of our operations and our legislative requirements to protect the waterways, marine life, fish, and waterfowl from possible impacts of boating and marina pollutants. We will continually assess and improve the management of our operations to limit our impacts on the surrounding environment.

'Fish Friendly Marina' - as a guest you agree to abide by the fish friendly requirements imposed on us as part of our Level 3 Fish Friendly status. Fishing from the marina is prohibited and fish waste is not permitted to be dumped or discarded on or near the marina – a fish cleaning table and waste bins are provided at the Soldiers Point Boat Ramp by the Port Stephens Council. Under hull scraping is not allowed under any circumstances. Some environmentally friendly cleaning agents are permitted – if in doubt ask a staff member or visit our website.

'No Single-Use Plastics' - as a guest you agree to help reduce and eventually eliminate the use of single-use plastics by 2025. Soldiers Point Marina is a progressive and environmentally conscious marina, determined to bring this date forward and are encouraging all businesses on site to eliminate single-use plastics as soon as practically possible. Plastic straws, cups and cutlery are not allowed to be used at the marina. Recycling facilities are available on site.

Dirty Water Harms the Environment, Spoils Boating Enjoyment & Hurts Marina Business.

It is the responsibility of every Soldiers Point Marina customer and EVERY employee to work together to keep our marina and boating environment clean. It is our commitment to do everything possible to discourage anyone from polluting while encouraging and helping customers do the right thing. All Employees are dedicated to eliminating contaminants before they enter the environment and have been trained to clean up any spoils which might occur.
